PLEASE TAKE NOTICE that Sealed bids will be received by the Purchasing Agent of the Township of North Bergen at the Purchasing Office, Room 211, Municipal Building, 4233 Kennedy Boulevard, North Bergen, New Jersey for the furnishing of the hereinafter described labor, material and equipment Renovation & Addition for the **North Bergen Municipal Court & Parking Authority at 4223 – 4229 BERGEN TURNPIKE, NORTH BERGEN, NEW JERSEY** and opened and read in public, in the County of Hudson, State of New Jersey 07047, at the Municipal Chambers, Municipal Building, 4233 Kennedy Boulevard, North Bergen, New Jersey on **April 19th, 2011 at 11:00 a.m.** prevailing time.

Bidding Documents may be examined and procured at the office of DMR Architects, 777 Terrace Avenue – 6th Floor, Hasbrouck Heights, NJ 07604, for the purpose of bidding. A non-refundable payment in cash or check to the order of “Township of North Bergen” in the sum of \$100.00 is required.

A Pre-bid conference will be held at the site (4223 – 4229 BERGEN TURNPIKE, NORTH BERGEN, NEW JERSEY) on **March 24nd, 2011 at 11:00 a.m.** Bidders are required to comply with the requirements of P.L. 1975, c. 127 (affirmative action).

In addition, all bidders shall provide a statement which shall set forth the names and addresses of all stockholders in the corporation or partnership who own 10% or greater interest therein. This information is required pursuant to Chapter 33, Public Law 1977, and cannot be waived or cured after the receipt of bids. Failure to comply will result in the REJECTION of the bid.

No bid will be accepted that does not conform to the specifications. Bids must be made on standard proposal forms provided with the documents and in the manner designated by the specifications; must be enclosed in sealed envelopes bearing the name and address of the bidder, must be DELIVERED to the Purchasing Agent for opening at the time and place aforesaid. Delivery of bid must be in person, Federal Express or Express Mail Service.

The Township of North Bergen reserves the right to waive technical deficiencies and to reject any and all bids if such rejection shall be found to be in the best interest of the Township, and to waive non-material informalities in any bid in such a manner as shall be deemed, in the judgment of the Township of North Bergen, to be in the best interest of the Township, all in conformity with the law.

Bidding shall be in conformance with the applicable requirements of N.J.S.A. 4011-16, as applied to single overall building contracts.

A bid guaranty shall accompany the bid proposal and shall be given in the amount of 10% of the base bid, but not in excess of \$20,000 unless otherwise required by law or regulation of the United States, and may be given at the option of the bidder by certified check, cashier’s check or a bid bond to the order of “Township of North Bergen” from a reputable insurance company authorized to do business in New Jersey.

Bids may be held by the Township of North Bergen for a period not to exceed sixty (60) days from the date of opening of bids for the purpose of reviewing the bids and investigating the qualifications of bidders, prior to awarding of the contract, unless said period is extended by mutual consent.
