IF YOU HAVE ALREADY OBTAINED A LICENSE, PLEASE DISREGARD THE ABOVE.

WE ASK YOUR COOPERATION IN **KEEPING YOUR DOG ON A LEASH** AT ALL TIMES WHEN THE DOG IS OFF YOUR PROPERTY. ADDITIONALLY, WE ASK THAT YOU **PICK UP AFTER YOUR DOG**, NOT BECAUSE IT IS THE LAW, BUT MORE IMPORTANTLY, IT WILL BE A GREAT SERVICE TO THE TOWNSHIP AND FOR THE HEALTH AND SAFETY OF ALL RESIDENTS WHO LIVE HERE. IF YOU NO LONGER HAVE A DOG, PLEASE NOTIFY THIS DEPARTMENT IMMEDIATELY.
